Note Verbale

The Federal Ministry for Europe, Integration and Foreign Affairs presents its compliments to the Ministry of Foreign Affairs of the Czech Republic and has the honour to acknowledge receipt of the latter's Note Verbale No. 314 927/2018-VO of 22 November 2018.

"The Ministry of Foreign Affairs of the Czech Republic presents its compliments to the Federal Ministry for European and International Affairs of the Republic of Austria and has the honor to propose the following:

The Ministry of Foreign Affairs of the Czech Republic proposes a modification of the Annex to the Agreement between the Government of the Czech Republic and the Government of the Republic of Austria on Mutual Representation in Issuing Visas (hereinafter referred to as the "Agreement"), signed in Prague on 31 May 2013, pursuant to Article 1 paragraph 2 of the Agreement. The modification reads as follows:

Representing Consular Posts:

• Embassy of the Czech Republic in Baghdad (Representation is limited to the visa applications of the holders of Iraqi diplomatic and service passports)

The Ministry of Foreign Affairs of the Czech Republic has the honor to propose that if the aforementioned is acceptable to the Austrian party, this note and the verbal note of the Federal Ministry for European and International Affairs of the Republic of Austria in reply constitute a modification of the Annex to the Agreement between the Government of the Czech Republic and the Government of the Republic of Austria on Mutual Representation in Issuing Visas which shall enter into force on the first day of the first month following the month in which the reply note was delivered.

The Ministry of Foreign Affairs of the Czech Republic avails itself of the opportunity to renew to the Federal Ministry for European and International Affairs of the Republic of Austria the assurances of its highest consideration."

The Federal Ministry for Europe, Integration and Foreign Affairs has the honour to inform the Ministry of Foreign Affairs of the Czech Republic that it accepts the proposal contained in the Ministry's Note Verbale to modify the Annex to the Agreement between the Government of the Republic of Austria and the Government of the Czech Republik on Mutual Representation in Issuing Visas. Pursuant to Article 1 paragraph 2 of the Agreement, this modification shall enter into force on the first day of the first month following the month in which the reply note was delivered.

The Federal Ministry for Europe, Integration and Foreign Affairs avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Czech Republic the assurances of its highest consideration.
