The provision "The representing Consular Post of Hungary in the State of Qatar, Singapore and Chongqing shall accept supporting documents in English, Hungarian or any other languages used by the visa issuing mission, the Consular Post of the Czech Republic in Iraq and in Mongolia shall accept the documents in English, Czech, and local language" is amended as follows: "The representing Consular Posts of Hungary shall accept supporting documents in English, Hungarian or any other languages used by the visa issuing mission, the representing Consular Posts of the Czech Republic shall accept the documents in English, Czech or any other languages used by the visa issuing mission."

The Ministry of Foreign Affairs of the Czech Republic proposes that if the aforementioned is acceptable to the Hungarian side, this note and the affirmative reply note constitute Amendment No. 2 to the Implementation Agreement between the Ministry of Foreign Affairs of the Czech Republic and the Ministry of Foreign Affairs of Hungary to the Agreement between the Government of the Czech Republic and the Government of the Republic of Hungary on the Mutual Representation by their Diplomatic Missions and Consular Posts in Processing Visas which shall enter into force on 1 January 2015.
