

The Embassy of the Czech Republic presents its compliments to the Foreign, Commonwealth and Development Office and has the honour to propose the express termination of the Agreement relative to the Importation from Great Britain into Czechoslovakia of Opium and similar Drugs concluded by the Exchange of Notes of 21 March 1921 and 4 August 1921.

If the aforementioned proposal is acceptable to the Government of the United Kingdom of Great Britain and Northern Ireland, the Embassy of the Czech Republic has further the honour to propose that this Note of the Embassy of the Czech Republic together with the Note of the United Kingdom in reply shall constitute the Agreement between the Government of the Czech Republic and the Government of the United Kingdom of Great Britain and Northern Ireland on the express termination of the Agreement relative to the Importation from Great Britain into Czechoslovakia of Opium and similar Drugs concluded by the Exchange of Notes of 21 March 1921 and 4 August 1921 (hereinafter "the Termination Agreement"). The Termination Agreement shall enter into force on the date of receipt of the Note in reply.

The Foreign, Commonwealth and Development Office of the United Kingdom of Great Britain and Northern Ireland presents its compliments to the Embassy of the Czech Republic in London and has the honour to acknowledge receipt of the Embassy's note No. 5849-1/2022-LOND of 27 June 2022 concerning the proposed termination of the Agreement relative to the importation from Great Britain into Czechoslovakia of Opium and similar Drugs, concluded by the Exchange of Notes of 21 March 1921 and 4 August 1921, (the "Agreement"), which reads as follows:

The Foreign, Commonwealth and Development Office has the honour to confirm that the above proposal is acceptable to the Government of the United Kingdom and that accordingly the Note of the Embassy and this Note in reply shall constitute the Agreement between the Government of the Czech Republic and the Government of the United Kingdom of Great Britain and Northern Ireland on the express termination of the Agreement relative to the importation from Great Britain into Czechoslovakia of Opium and similar Drugs, concluded by the Exchange of Notes of 21 March 1921 and 4 August 1921 (the "Termination Agreement"), which shall enter into force on the date of receipt by the Embassy of this Note. The Agreement shall accordingly be terminated on the same date.

The Foreign, Commonwealth and Development Office of the United Kingdom of Great Britain and Northern Ireland avails itself of this opportunity to renew to the Embassy of the Czech Republic in London the assurances of its highest consideration.
